Sealed bids will be received by the Mecosta County Road Commission administrative staff at 120 N. DeKrafft Ave., Big Rapids, Michigan, 49307 until 3:30 p.m. Monday, March 12, 2018 for Annual Bids. All bids will be opened Tuesday, March 13, 2018 at 9:30 am. All bids will be reviewed by the Board of County Road Commissioners Tuesday, March 20, 2018. Your proposal must be sealed with the envelope clearly marked with your company name and the words "Underbody Scraper Blades, Wing Plow Blades, and Plow Shoes" on the outside.

MATERIAL:

Supplier to submit specifications for blades with their bid. All punch and drilled holes shall be verified by the supplier to match diameter and spacing required on current fleet items. Road Commission will approve bid design prior to ordering shipment, if requested by the successful bidder.
