## RE: PETITION TO ABANDON A COUNTY ROAD

You have indicated an interest in filing a petition with the Mecosta County Road Commission to abandon a road. Road abandonment is a very technical procedure strictly governed by state statute. You may wish to seek legal counsel.

The process of abandonment covers all roads under the County Road Commission's jurisdiction. It contemplates three situations:

- A. A road with no structures (buildings), all owners signing the petition.
- B. A road with structures, all owners and occupants on the road signing the petition.
- C. A road with or without structures, not all owners or occupants signing the petition.

If yours is the third (C) situation, to support your petition you must obtain the signatures of seven or more property owners living in the township where the road to be abandoned is located.

If the abandonment results in a road becoming dead end, the County Road Commission, as a condition to granting the abandonment, may request that enough land to construct a turn-around area be granted to the Road Commission.

When filing your petition, please note the last paragraph in the petition. This requires you to submit a certified list of all owners of record of land abutting the portion of the road requested to be abandoned. The certified list must state the descriptions of the parcels.

The filing fee is due and payable when you file your petition. It will be reviewed by the Road Commission as soon as possible. If it is found to be deficient, you will be notified promptly. Once your petition is accepted by the Road Commission, you will be notified of a hearing date.

Generally, if the road to be abandoned either touches or terminates at lakes or streams, no abandonment action will be taken by the Road Commission. The Road Commission has no jurisdiction over private roads in plats.
